RE: 22 DE Reg. 337 [DDOE Proposed Regulation - Reporting Expulsions to DMV (November 1, 2018)]

Dear Ms. Cunningham:

The State Council for Persons with Disabilities (SCPD) has reviewed Delaware Department of Education (DDOE) proposed regulation is intended to amend 14 DE Administrative Code 616 Uniform Due Process Procedures for Alternative Placement Meetings and Expulsion Hearings to align with changes made by House Bill 402 of the 149<sup>th</sup> General Assembly which eliminated the requirement for a school superintendent to notify the Division of Motor Vehicles when a student was expelled from a public school for the purposes of suspending or refusing to issue or review an expelled student's driver's license.

The proposed regulation was published as 22 DE Reg. 337 in the November 1, 2018 issue of the Register of Regulations. The SCPD has the following observations.

House Bill 402 repealed a law which prevented the Division of Motor Vehicles from issuing driver's licenses to students who were expelled from public school. It also eliminated the requirement that public school superintendents inform the Division of Motor Vehicles of student expulsions.<sup>2</sup>

The proposed amendment updates 14 DE Admin. Code 616 in light of House Bill 402; it eliminates the requirement that public school districts and charter schools inform the Division of Motor Vehicles when students are expelled.
